Natural Climate Solutions Proviso


- \$70,000,00 for purchase of replacement trust lands/exchange for encumbered lands
- 2,000 acres of structurally complex, carbon dense forestlands
- Prior to the transfer, the replacement lands must be identified, and the County must provide its concurrence



Natural Climate Solutions - Opportunity For County


- Replacement lands are of equal value
 - Additional acres for beneficiary
 - Long term benefits
- Reduces conversion risk
- Conservation benefits






Why Structurally Complex, Carbon Dense Forests Matter:


- Mature forests store AND sequester more carbon¹
 - Tree carbon accumulation increases with tree size
 - Net C storage rates at ecosystem level increase in spite of stand scale saturation
- Accurate accounting shows us that ecosystem carbon loss at time of harvest is not matched through "storage" in harvested wood products²
- Mature forests provide a wealth of other ecosystem services
 - Water, habitat, micro-climate, above and below ground biodiversity, cultural use








Figure 25 Maturation I: Pre-Euro-American settlement






Definition: Structurally Complex, Carbon Dense Forests = Maturation 1

- Large Trees
 - Dominant cohort trees at 60-70% of their potential height and >20" dbh
 - Some dominant trees > 30" dbh
- Canopy diversity
 - Range of heights, diameters and species
- Understory diversity
 - Understory recruitment
 - Understory complexity





Structurally Complex Forests:

- Large Trees
- Canopy diversity
 - Range of heights, diameters and species
- Understory diversity
- Ecosystem legacies
 - Snags, large downed wood




Mature forests in Western Washington are rapidly disappearing, as the Department of Natural Resources (DNR) auctions them off on a monthly basis to the highest bidding timber company. The Center for Responsible Forestry (CRF) advocates for the creation of a new mature forest conservation policy on lands managed by DNR and works with counties to participate in current conservation programs. This report is a work in progress. Our goal is to provide the most up to date information on planned DNR timber sales and current management practices, but this is subject to change as DNR frequently modifies future harvest plans.
